PURCHASED POWER COST ADJUSTMENT CLAUSE
SCHEDULE PPCA
(RATE CODE 2000)

AVAILABILITY

This rate is available throughout the entire territory served by the Commissioners of Public Works ("CPW").

APPLICABILITY

This rate schedule is applicable to all and becomes a part of all of the CPW's retail electric service rate schedules and is applicable to all kWh sales thereunder.

BILLING RATE

The monthly bill computed under the appropriate retail rate schedule will be increased or decreased by an amount equal to the result of multiplying the kWh used by the Purchased Power Cost Adjustment factor ("PPCA").

The PPCA will be calculated as follows:

$$PPCA = (Pm/Sm) - Base Rate$$

<i>PPCA</i>	=	Adjustment factor in dollars per kWh rounded to nearest one thousandth of a cent applicable to bills rendered during the current Billing Period.
<i>Pm</i>	=	Total estimated Applicable Purchased Power costs.
<i>Sm</i>	=	Energy sales, excluding municipal and CPW usage for the projected billing period.
<i>Base Rate</i>	=	\$0.0451

BILLING PERIOD

The billing period shall be monthly.

APPLICABLE PURCHASED POWER

Applicable Purchased Power shall be;

- (i) the CPW's total estimated cost of purchased power from Duke Energy Carolinas and the Southeastern Power Administration ("SEPA"), plus
- (ii) transmission charges from Duke Energy Transmission, plus
- (iii) any applicable adjustments applied to purchased power for the projected billing period, plus
- (iv) monthly amounts estimated by the CPW to reduce volatility in the PPCA charges, which amounts shall equal to zero over the calendar year, plus
- (v) amounts described below in Special Provisions, plus
- (vi) an amount to correct for any over-recovery or under-recovery of the actual Applicable Purchased Power costs during a preceding billing period. This over- or under-recovery shall be determined as the difference between the actual Applicable Purchased Power cost during such preceding billing period and the estimated Applicable Purchased Power costs established for such preceding billing period.

SPECIAL PROVISIONS

Any amount charged or credited to the CPW by Duke or Duke Energy Transmission for an annual true-up or true-down under the CPW's power supply arrangement with Duke may be recovered or returned through the PPCA at the discretion of the CPW. Any true-ups or true-downs charged or credited to the PPCA may be offset in whole or in part by amounts provided from or to the Electric Rate Stabilization Fund. In addition, the CPW may reduce the monthly purchased power costs to offset the portion of base rates that is designated for the Electric Rate Stabilization Fund accrual once the Electric Rate Stabilization Fund cap is reached.

RESIDENTIAL ELECTRIC SERVICE
SCHEDULE E-R
(RATE CODE 2100)

The Commissioners of Public Works ("CPW") shall charge and collect for residential electric service on the basis of this rate schedule. The Power Cost Adjustment Clause and Rules and Regulations for Electric Service are incorporated by reference as a part of this rate schedule.

AVAILABILITY

This rate schedule is available to domestic electric customers within the territory served by the CPW.

The obligations of the CPW in regard to supplying electric service are dependent upon its securing and retaining all necessary rights-of-way, privileges and permits for the delivery of such service. The CPW shall not be liable to any customer or applicant for electric service in the event it is delayed in, or is prevented from, furnishing the electric service by its failure to secure and retain such rights-of-way, privileges and permits.

APPLICABILITY

This rate schedule is applicable to all electric service exclusively for domestic purposes to individual (single-family) private residences, condominiums, mobile homes, individually metered apartment units and farm homes. This rate schedule is not applicable to businesses, licensed boarding or rooming houses, fraternity or sorority houses advertised as such, educational institutions or facilities, or apartment houses if served by a single meter. Standby or resale service is not permitted under this rate schedule.

CHARACTER OF SERVICE

Service under this rate schedule shall be alternating current, 60 Hertz, single phase, at the CPW's option of standard available voltages. When the CPW deems necessary, three phase service shall be provided at the CPW's option of standard available voltages. Where three phase service is not available, it may be extended to the customer's premises at the CPW's discretion. The customer may be required to participate in the expense of extending such service.

AVAILABILITY

This rate schedule is available to non-domestic electric customers within the territory served by the CPW. The obligations of the CPW in regard to supplying electric service are dependent upon its securing and retaining all necessary rights-of-way, privileges and permits for the delivery of such service. The CPW shall not be liable to any customer or applicant for electric service in the event it is delayed in, or is prevented from, furnishing the electric service by its failure to secure and retain such rights-of-way, privileges and permits.

APPLICABILITY

This rate schedule is applicable to non-domestic customers who have a maximum metered demand less than 30 kW. Standby or resale service is not permitted under this rate schedule.

Service under this rate schedule shall be 60 Hertz through one meter, at one delivery point, at the CPW's option of standard available voltages. When the CPW deems necessary, three phase service shall be provided at the CPW's option of standard available voltages. Where three phase service is not available, it may be extended to the customer's premises at the CPW's discretion. The customer may be required to participate in the expense of extending such service.

Motors of less than 5 H.P. may be single-phase. All motors of more than 5 H.P. must be equipped with starting compensators.

The CPW shall not be liable to any customer or applicant for electric service in the event it is delayed in, or is prevented from, furnishing the electric service by its failure to secure and retain such rights-of-way, privileges and permits.

When the CPW deems necessary, three phase service shall be provided at the CPW's option of standard available voltages. Where three phase service is not available, it may be extended to the customer's premises at the CPW's discretion. The customer may be required to participate in the expense of extending such service. Motors of less than 5 H.P. may be single-phase. All motors of more than 5 H.P. must be equipped with starting compensators.

The Commissioners of Public Works ("CPW") shall charge and collect for outdoor area lighting service on the basis of this rate schedule. The Power Cost Adjustment Clause and Rules and Regulations for Electric Service are incorporated by reference as a part of this rate schedule.

AVAILABILITY

This rate schedule is available to non-domestic and domestic electric customers within the territory served by the CPW. The obligations of the CPW in regard to supplying electric service are dependent upon its securing and retaining all necessary rights-of-way, privileges and permits for the delivery of such service. The CPW shall not be liable to any customer or applicant for electric service in the event it is delayed in, or is prevented from, furnishing the electric service by its failure to secure and retain such rights-of-way, privileges and permits.

APPLICABILITY

This rate schedule is applicable to year-round outdoor security lighting of areas not covered by any other rate schedule. Lighting to be provided under this rate schedule shall be at locations which are easily and economically accessible to the CPW equipment and personnel for construction and maintenance. Lamps will be operated from dusk to dawn, or approximately 4,000 hours per year per lamp.

CHARACTER OF SERVICE

Service under this rate schedule shall be alternating current, 60 Hertz, single phase, at the CPW's option of standard available voltages. Standby or resale service is not permitted under this rate schedule.

DESCRIPTION:

Installation of standard, non-decorative high pressure sodium or metal halide rental lighting. Installation options include placement on existing pole with overhead line, placement on a new pole with overhead line, and placement on new pole with underground line.

CHARGE FOR NON-STANDARD, DECORATIVE LIGHTING:

The monthly charges set forth above reflect fees for standard, non-decorative lighting fixtures and poles. The CPW will, at the request of the customer, install decorative light fixtures and/or poles at an extra monthly charge equal to 1.4% of incremental cost difference between the standard light fixture/pole and the requested decorative light fixture/pole.

POWER COST ADJUSTMENT

The Power Cost Adjustment Clause shall be applied to sales under this schedule based on the estimated monthly kWh for the applicable light fixture.

SPECIAL CONDITIONS

The CPW will furnish, operate, and maintain the facilities required for service under this rate schedule. Service at locations where existing CPW owned poles and facilities are not available will be made at the discretion of the CPW. The following conditions will apply to all facilities installed by the CPW under this rate schedule:

- a. Extensions of any lighting facilities will be made by the CPW only where, in the opinion of the CPW, the annual revenue justifies the estimated cost including all appropriate overheads.
- b. New area lighting facilities shall be of a form and substance consistent with the CPW's approved standard configuration for area lighting at the time of the Customer's application for service. Where non-standard lighting configuration is requested by the customer, all maintenance and replacement costs shall be included in the monthly fees set forth in the rate schedule above.
- c. Customers requesting service under this rate schedule will be required to execute contract for service with a minimum term of 12 months.

AVAILABILITY

This rate schedule is available to incorporated municipalities within the territory served by the CPW. The obligations of the CPW in regard to supplying electric service are dependent upon its securing and retaining all necessary rights-of-way, privileges and permits for the delivery of such service. The CPW shall not be liable to any customer or applicant for electric service in the event it is delayed in, or is prevented from, furnishing the electric service by its failure to secure and retain such rights-of-way, privileges and permits.

APPLICABILITY

This rate schedule is applicable to incorporated municipalities for electric power and energy used for the operation of municipally owned and operated office buildings, street lights and other municipal functions. Standby or resale service is not permitted under this rate schedule.

CHARACTER OF SERVICE

Service under this rate schedule shall be 60 Hertz through one meter, at one delivery point, at the CPW's option of standard available voltages. When the CPW deems necessary, three phase service shall be provided at the CPW's option of standard available voltages. Where three phase service is not available, it may be extended to the customer's premises at the CPW's discretion. The customer may be required to participate in the expense of extending such service. Motors of less than 5 H.P. may be single-phase. All motors of more than 5 H.P. must be equipped with starting compensators.

SPECIAL CONDITIONS

Before wiring any premises or purchasing equipment for same, the customer shall give the CPW notice in writing of the location of the building, together with a list of electrical devices to be used thereon, and shall ascertain in the character of service available at such premises. The CPW shall specify the voltage and type of electrical service to be furnished, as well as the location of the meter and the point where the service connections shall be made.

DETERMINATION OF BILLING DEMAND

The "Billing Demand" for the billing period shall be the maximum integrated thirty minute demand recorded during the previous three periods including the billing period for which the bill is rendered.

POWER COST ADJUSTMENT

The above energy charges will be adjusted in accordance with the formula specified in the Power Cost Adjustment Clause.

MINIMUM CHARGE

The minimum monthly charge shall be the "Facility Charge".

SALES TAX

Any applicable sales tax will be added to the monthly bill as determined above.

POWER FACTOR CORRECTION

When the average monthly power factor of the customer's power requirements is less than eighty five percent (85%) the CPW may correct the integrated demand in kW for that month by multiplying by eighty five percent (85%) and dividing by the average power factor in percent for that month.

INTERRUPTION OF SERVICE

The CPW will make reasonable provisions to ensure satisfactory and continuous service, but does not guarantee a continuous supply of electrical power and energy and shall not be liable for damage occasioned by interruptions of service or failure to commence delivery caused by acts of God, or the public enemy, or for any cause reasonably beyond its control, including, but not limited to the failure or breakdown of facilities, floods, fire, strikes, or action or orders of any agency having jurisdiction in the premises, or for interruptions which are necessary for inspection, repair, or changes in equipment or facilities of the CPW or its bulk power suppliers. The customer shall notify the CPW immediately of any defects, trouble or accident which may in any way affect the delivery of electric service by the CPW.

PAYMENT

The due date of the bill shall be 21 days from the billing date. Payment must be received at the Monument Street office of the CPW by 5:00 PM on the due date.
